9. **Promotion Period:** Enter between 00:01 BST on the 19 April 2022 and 23:59 BST on the 3 May 2022 inclusive.
4. **To Enter:** Visit <https://www.skoda.co.uk/discover/cycling-keep-me-informed> answer the question and complete the online form to provide your details (name, email address, and contact telephone number) to be entered into the Prize Draw.
5. Maximum of 1 entry is permitted per person during the Promotion Period. No person may win more than 1 Prize.
